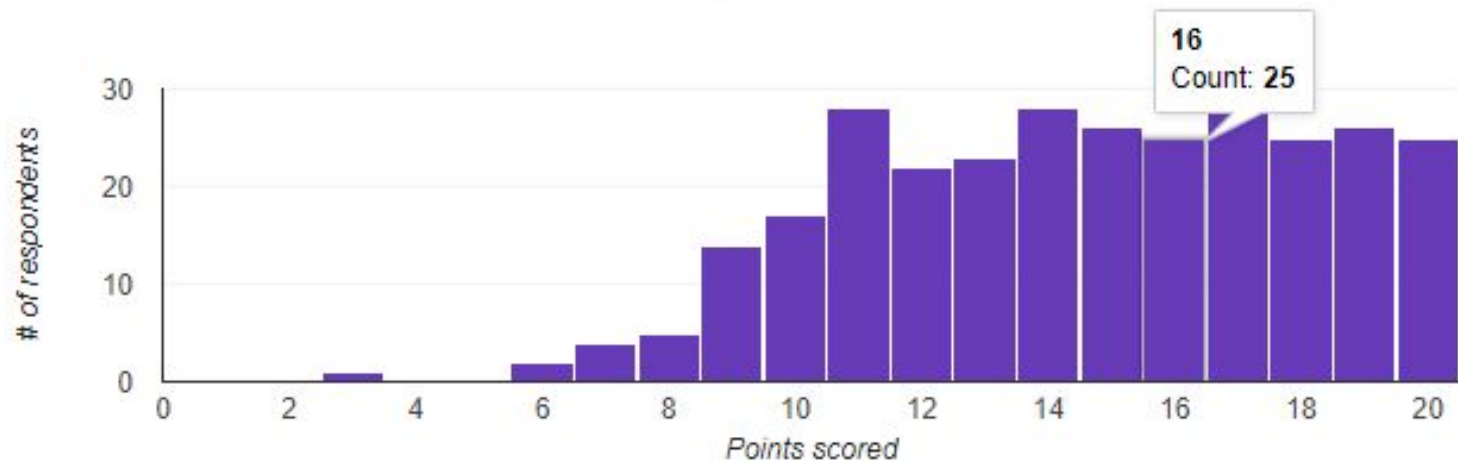

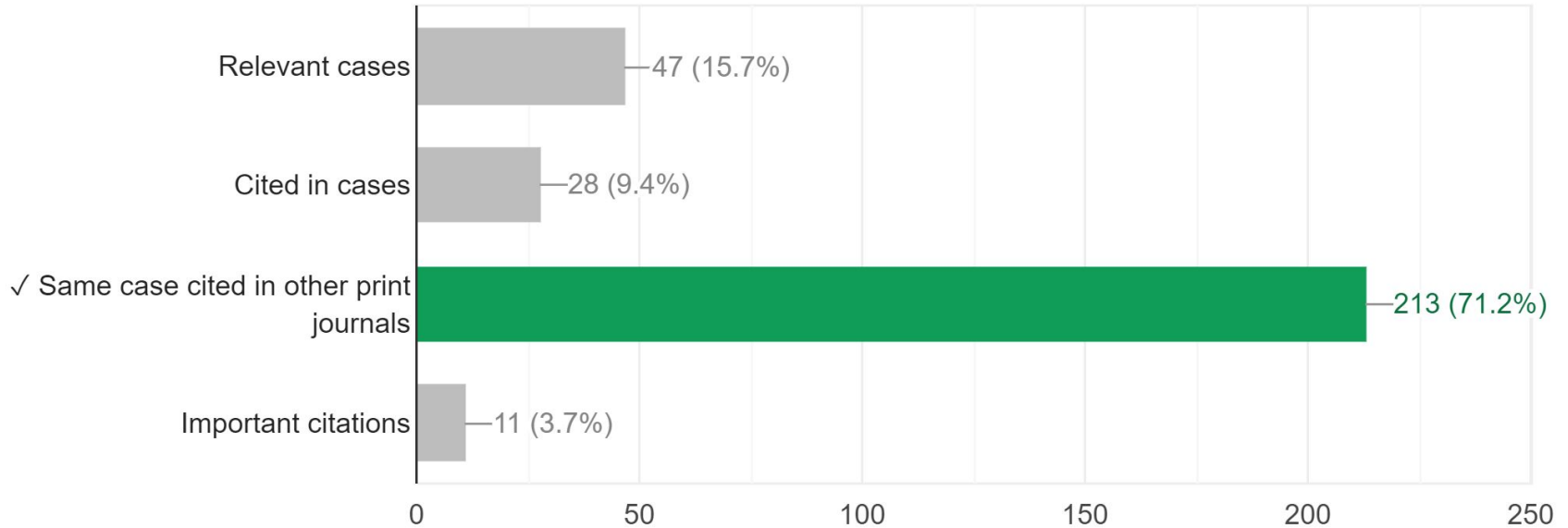

Total points distribution



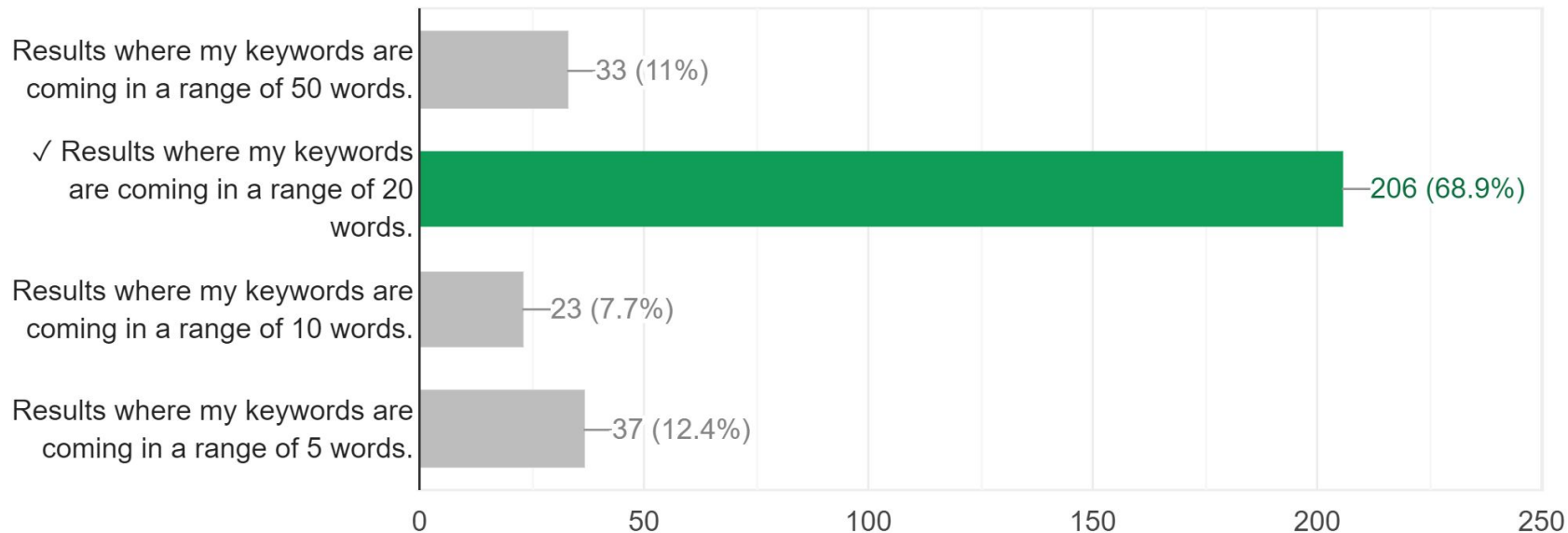

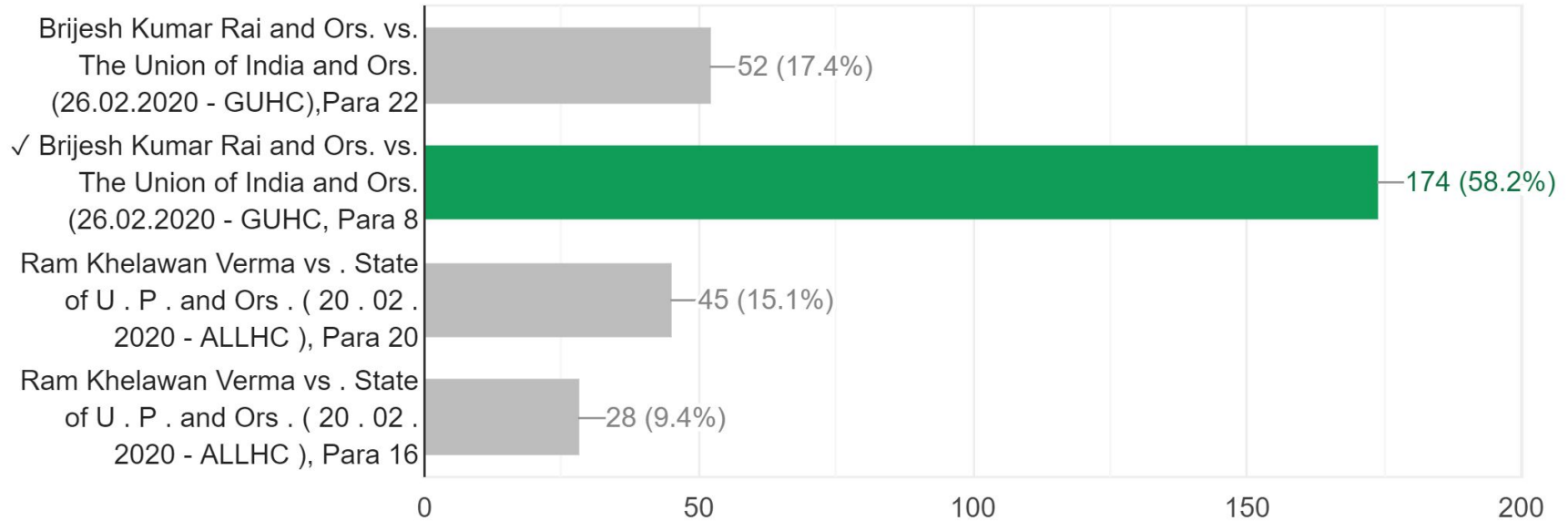

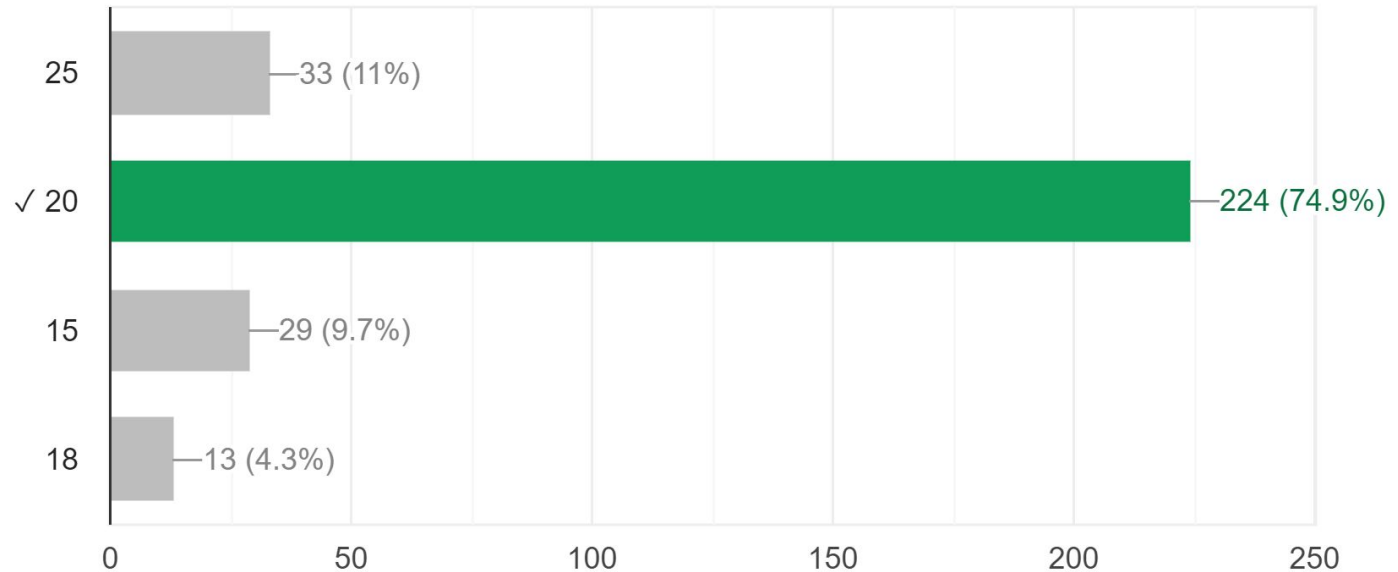
